

Pennsylvania Dairy Farmers Soccer Sweepstakes
Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Pennsylvania Dairy Farmers Soccer (the "Sweepstakes") begins at 10:00 a.m., Eastern Time ("ET") Saturday, March 1, 2025, and ends at 11:59 p.m. ET on Saturday, September 20, 2025, ("Sweepstakes Period"). Sweepstakes is sponsored by American Dairy Association North East (the "Sponsor" and "Administrator"), Interstate Place II, 100 Elwood Davis Road, North Syracuse, NY 13212. Entering the Sweepstakes constitutes an entrant's full and unconditional agreement to and acceptance of these Official Rules.

ELIGIBILITY: The Sweepstakes is open to legal residents of New York, New Jersey, Pennsylvania, Delaware, Maryland, District of Columbia, and Northern Virginia who have attained the age of eighteen (18) years old as of the Sweepstakes start date. Employees, officers, and directors of the Sponsor and their respective immediate family members and household and those of any corporate affiliates, subsidiaries, advertising and promotion agencies of the Sponsor and the Administrator, and any other entities directly associated with this Sweepstakes (together the "Released Parties") are not eligible to participate. All federal, state, and local laws and regulations apply. **Void where prohibited.**

HOW TO ENTER: During the Sweepstakes Period, eligible participants are invited to enter the Sweepstakes by completing an online entry at www.americandairy.com/union. Once entrants have completed the entry, they will automatically be entered with one (1) entry into the Sweepstakes. Individuals who are unable to access or prefer not to enter through the website may enter the Sweepstakes without charge by sending a postcard containing their name, address, the subject line Pennsylvania Dairy Farmers Soccer to the Sponsor at American Dairy Association North East, Interstate Place II, 100 Elwood Davis Road, North Syracuse, NY 13212.

To be eligible to win, entries must be received by Sponsor during the Sweepstakes period. For purposes of this Sweepstakes, an entry is "received" when an online entry form is completed at www.americandairy.com/union or when the United States Postal Service delivers an entry via postcard to the Sponsor at the address above. Receipt of entries may not be acknowledged by the Sponsor. Submissions which are not consistent with these Official Rules will be disqualified. All participants in the Sweepstakes agree that the Sponsor may use the content in their online entry including all or a portion of their submission, their likeness, for any proper purpose, including, without limitation, for Sponsor's advertising/promotional purposes. Any personally identifiable information collected during an entrant's participation in this Sweepstakes, including name and email address, will be collected, and used by Sponsor, its respective affiliates, agents, and marketers for purposes of the administration and fulfillment of the Sweepstakes as described in these Official Rules and for Sponsor's marketing and business purposes, including email marketing. SUBMISSION GUIDELINES: Entrants must fill out the entry form at www.americandairy.com/union including name, email address, and state of residency to be officially entered. Entries may not contain any description, image, or depiction of the following: (i) materials which include or constitute trademarks, trade names or copyrighted works created or owned by any person or entity other than the entrant; (ii) materials bearing profanities, or bearing the name or likeness of any celebrity, living or dead; (iii) materials which contain visible identifiable or potentially identifiable information, including but not limited to, phone numbers, website links, street addresses, email addresses or license plate numbers; (iv) behavior inappropriate for a general audience; (v) any depiction of real or simulated sexual acts; (vi) violence in any form; (vii) materials which violate anyone's reasonable privacy expectations, violate any known agreement, or which are defamatory in nature; (viii) materials which are derogatory to Sponsor, or any affiliated entity or person; (ix) materials which are discriminatory based on race, religion, national origin, physical disability, age, sex, or

sexual orientation or preference; (x) materials in which any person identifiably appears unless the entrant has obtained an appropriate written release from such person granting all rights required herein; and, (xi) materials which do not comply with all other requirements in these Official Rules.

Sponsor reserves the right to reject or disqualify any entry which Sponsor, in its sole and absolute discretion, determines to be inconsistent with the letter or spirit of the Official Rules or potentially damaging to its, the Sweepstakes, or another's image or reputation.

DRAWINGS AND NOTIFICATIONS: At the end of the Sweepstakes Period, a random drawing will take place from all eligible entries received to determine the prize winner. All drawings will be conducted by the Sponsor, whose decisions are final and binding in all matters relating to this Sweepstakes. The Sponsor will randomly select a total of one (1) winner from among the eligible entries received from all methods of entry. Sponsor will select a winner by Friday, September 26, 2025. The decisions of Sponsor are final and binding in all matters relating to the Sweepstakes. The odds of winning a prize depend on the total number of eligible entries received. The winner will be contacted by the Sponsor via email and will be notified by Monday, September 29, 2025.

PRIZES: One (1) grand prize winner will receive a Philadelphia Union jersey autographed by multiple players and four (4) tickets to a future Philadelphia Union game.

PRIZE CONDITIONS: If a prize or prize notification is returned as unclaimed or undeliverable if a winner does not respond to Sponsor's notification to claim their prize within 7 calendar days from the date Sponsor first gives notice via email, or if a winner fails to complete and return any tax forms or other documentation reasonably requested by Sponsor within the time period specified by Sponsor (which shall not be less than 7 calendar days), or if a winner is determined not to have complied with these Official Rules, then such person shall be disqualified and their prize shall be awarded to an alternate winner selected by random drawing. All taxes, if applicable, are the sole responsibility of the winner. A winner's entry in the Sweepstakes and acceptance of the prize offered constitutes permission (except where prohibited) for the Sponsor to use such winner's name, photograph, likeness, statements, biographical information, voice and address (city and state), as well as the photos and social media posts, in all forms of media, in perpetuity, without notice or further compensation. No substitution or transfer of prize or election of cash in lieu of prize will be permitted. The Sponsor reserves the right at its sole discretion to substitute any part of the prize package with another prize of equal or greater value in the event that the prize (or any component thereof) is not available. Decisions of the Sponsor are final and binding.

LIMITATIONS OF LIABILITY: If for any reason this Sweepstakes is not capable of running as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and to select and award any prizes using all non-suspect eligible entries received. Sponsor shall have no responsibility or liability for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries, or for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website or application, or any combination thereof, including any injury or damage to participant's or any other person's computer, smartphone or other device relating to or resulting from participation in the Sweepstakes or downloading any materials in the Sweepstakes.
