

Rochester Half Marathon Gift Gard Sweepstakes
Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Rochester Half Marathon Gift Gard Sweepstakes (the "Sweepstakes") begins at 6:00 p.m., Eastern Time ("ET") Friday, September 19, 2025, and ends at 4:00 p.m. ET on Saturday, September 20, 2025, ("Sweepstakes Period"). Sweepstakes is sponsored by American Dairy Association North East (the "Sponsor" and "Administrator"), Interstate Place II, 100 Elwood Davis Road, North Syracuse, NY 13212. Entering the Sweepstakes constitutes an entrant's full and unconditional agreement to and acceptance of these Official Rules.

ELIGIBILITY: The Sweepstakes is open to legal residents of New York, New Jersey, Pennsylvania, Delaware, Maryland, District of Columbia, and Northern Virginia who have attained the age of eighteen (18) years old as of the Sweepstakes start date. Employees, officers, and directors of the Sponsor and their respective immediate family members and household and those of any corporate affiliates, subsidiaries, advertising and promotion agencies of the Sponsor and the Administrator, and any other entities directly associated with this Sweepstakes (together the "Released Parties") are not eligible to participate. All federal, state, and local laws and regulations apply. **Void where prohibited.**

HOW TO ENTER: During the Sweepstakes Period, eligible participants are invited to enter the Sweepstakes by completing an online entry at www.americandairy.com/rochester-half-marathon/. Once entrants have completed the entry, they will automatically be entered with one (1) entry into the Sweepstakes. Individuals who are unable to access or prefer not to enter through the website may enter the Sweepstakes without charge by sending a postcard containing their name, address, and state of residency with the subject line Rochester Half Marathon to the Sponsor at American Dairy Association North East, Interstate Place II, 100 Elwood Davis Road, North Syracuse, NY 13212.

To be eligible to win, entries must be received by Sponsor during the Sweepstakes period. For purposes of this Sweepstakes, an entry is "received" when an online entry form is completed at www.americandairy.com/rochester-half-marathon/ or when the United States Postal Service delivers an entry via postcard to the Sponsor at the address above. Receipt of entries may not be acknowledged by the Sponsor. Submissions which are not consistent with these Official Rules will be disqualified. Any personally identifiable information collected during an entrant's participation in this Sweepstakes, including name and email address, will be collected, and used by Sponsor, its respective affiliates, agents, and marketers for purposes of the administration and fulfillment of the Sweepstakes as described in these Official Rules and for Sponsor's marketing and business purposes, including email marketing. SUBMISSION GUIDELINES: Entrants must fill out the entry form at www.americandairy.com/rochester-half-marathon/ including name, email address, and state of residency to be officially entered.

Sponsor reserves the right to reject or disqualify any entry which Sponsor, in its sole and absolute discretion, determines to be inconsistent with the letter or spirit of the Official Rules or potentially damaging to its, the Sweepstakes, or another's image or reputation.

DRAWINGS AND NOTIFICATIONS: At the end of the Sweepstakes Period, a random drawing will take place from all eligible entries received to determine the prize winners. All drawings will be conducted by the Sponsor, whose decisions are final and binding in all matters relating to this Sweepstakes. The Sponsor will randomly select a total of two (2) winners from among the eligible entries received from all methods of entry. Sponsor will select a winner by Friday,

September 26, 2025. The decisions of Sponsor are final and binding in all matters relating to the Sweepstakes. The odds of winning a prize depend on the total number of eligible entries received. The winners will be contacted by the Sponsor via email and will be notified by Wednesday, October 1, 2025.

PRIZES: Two (2) grand prize winners will receive a \$250 Fleet Feet gift card.

PRIZE CONDITIONS: If a prize or prize notification is returned as unclaimed or undeliverable if a winner does not respond to Sponsor's notification to claim their prize within 7 calendar days from the date Sponsor first gives notice via email, or within fifteen (15) calendar days from the date Sponsor first gives notice by first class mail, if a winner fails to complete and return any tax forms or other documentation reasonably requested by Sponsor within the time period specified by Sponsor (which shall not be less than 7 calendar days), or if a winner is determined not to have complied with these Official Rules, then such person shall be disqualified and their prize shall be awarded to an alternate winner selected by random drawing. Sponsor shall have no responsibility or liability for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries, or for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website or application, or any combination thereof, including any injury or damage to participant's or any other person's computer, smartphone or other device relating to or resulting from participation in the Sweepstakes or downloading any materials in the Sweepstakes. "Authorized account holder" is defined as the natural person who is assigned to the profile by the email platform provider.
